PRESIDENT'S REPORT FOR YEAR 2023

Ladies and gentlemen,

Welcome to the 56th Annual General Assembly on this 14th March 2024.

First and foremost, I would like to pay a tribute to two key members who are no longer with us.

On 26.07.2023, our Secretary Mr. Rajendra Prasad Gangoosinh, a dedicated teacher and school inspector who has been on our committee for 12 years, passed away. He will be remembered for his presence, support and dedication specially when attending airport duty on departure and arrival of patients who went abroad for their surgical treatment. A few months later his wife, Shilla, former Director of the Hindu Girls College left us.

On 27.02.2024, SACIM suffered a great loss. Its former President Dr. Bhawan Amrit Rajkomar, Consultant Paediatrician passed away. Amrit was the back bone of SACIM for many years and he joined SACIM in 1990. He served as a Committee Member and also President on several occasions resulting in 17 years in this position. He participated in the initial medical examination prior to acceptance of care by SACIM as well as the regular check-ups of children who had been operated. Whenever required, he accompanied whole heartedly abroad those children who needed medical assistance.

We are very grateful to both of them for their generous contribution to our children and to our NGO. We convey our deepest sympathy to their families.

In 2023, we have sent abroad 5 patients (3 for surgical treatment and 2 for review) and 5 patients were operated in local private clinics and among them 3 were cases of lifesaving operations. Unfortunately, one baby did not survive.

A big thanks to Dr. Naveen Tahasildar, Orthopaedic Spine Surgeon who successfully performed a complex surgery on a SACIM patient and Dr. Vikas Ellur, Consultant Paediatric Orthopaedic Surgeon for the operation long overdue because of the Covid pandemic, of another patient for a second time.

We are most grateful to the Children of Mauritius Medical and Surgical Support Association, Western Australia (COMSSA-WA) for welcoming two of our patients of Rodrigues for their eyes review after four years and also the financial assistance for the surgeries of two patients in a local private clinic. A big thank you to the team in Perth.

Thank you, Dr. Kevin Teerovengadum, Paediatric Surgeon, Dr. Mrs. Anne Moro, Pediatric Plastic Surgeon and Dr. Mohamed L'Kaissi, Paediatric Surgeon who are of great support. The diagnosis and expertise are very important for us.

Re-education plays an important role for welfare, thank you to Mr. Sumun Houzaifah, Physiotherapist who look after our patients and Dr. Fakim, Ophthalmologist, for the care he is providing to our patients for over 15 years now.

In order to assess a child's parental situation, a social enquiry report is done and this is very important as it is one of our conditions for acceptance. We, therefore wish to thank the Probations officers of the Ministry of Social Security, National Solidarity & Reform Institutions for the prompt submission of their report and transparency.

Dr. Francois Leung, Dr. Manseej Purang and Dr. B. Amrit Rajkomar have provided medical follow-up to 36 patients during the year 2023. We thank them for the time and guidance that they have generously given to SACIM children.

The SACIM – Website is ready and I wish to mark my appreciation to the team comprising a few Board members and the administrative staff who have been working hard. Having



so many years of existence we had to take time to give the proper insights of our long and vast NGO. Thank you to Mrs. Valérie Bouic our previous Nurse/Committee Member and President in 1987, 1988 and 1989 for the notes on the historical part on SACIM which has been very useful. The new website will be colourful, lively and user friendly.

The Board took the decision to put on sale the motor vehicle Suzuki Celerio which was donated in 2012 by ENL. The increase cost of maintenance and its low level of use were the reasons for its sale. A tendering exercise was held and the car was sold for Rs 115,550 on 17.10.2023.

On 8th August, 2023 Mr. Youdish M. Sookram, Managing Director and Mr. Nuvin Jugessar of AmCare based in Quatre Bornes made a presentation of the services offered by them for those in need of an overseas medical treatment.

We also had the visits from India of Mr. Farouk from the Dr Rela Institute & Medical Centre of Chennai and the local liaison officer, Dr. Thiruven Armoogum on 9th and 10th August 2023 and Mr. Koushik Guha, of the Rainbow Children's Hospital, on 24.08.2023. Both medical centres offer a good quality healthcare service which is worth to explore in the future if necessary.

The National Social Inclusion Foundation (NSIF) is our main financial support and we are grateful for their trust in our projects submitted.

We also obtain financial support from other companies through their Corporate Social Responsibility (CSR) programme as well as private donors. We thank them for their confidence in our mission.

A car drifting show took place on 24.06.2023 on the parking of the Anjalay Coopen Stadium and this is the 2nd edition of the Drive for SACIM. The show was a real success and the fund raised of Rs 606,927.35 was donated to SACIM. We are grateful to Mr. Yassir Khodabocus and his team for their trust and contribution. Thank you, Dr. Francois Leung, for introducing this project to us.

A total of Rs 3,415,772 were spent as medical and surgical treatment including payment of hospital abroad, local private clinic, post-operative treatment, doctors' fee, physiotherapy, purchase of medicines and eye drops, injections and X-rays.

We organised the Christmas Fun day on the 9th December, 2023. We are most grateful to the Rotaract of Port Louis and Interact of Port Louis for their help in the preparation and organisation of various entertainment such as a bingo party, paintings on clay pots for the event. Without our sponsors we would not have been able to welcome



the children and their parents. We wish to thanks the Special Mobile Force, Maurilat, SKC Surat, Quality Beverages, Mr. V. Annamalai (the magician), Mr. K. Moodely (caterer), and the Mauritius Broadcasting Corporation. I also wish to thanks the Board members and their families and the staff members for the contribution in the organisation.

Father Christmas as expected was the highlight with the generous gifts offered to our SACIM children. Afterwards, a lunch pack was offered as well as fruits and dessert to everyone.

In spite of the heavy rain the party was a success.

I would like to extend my gratitude to Husna Ramjanally for the help she has proposed by writing several articles in the newspapers "Le Mauricien and Week End". This is so important to make visible to the public, our vision and the wonderful work done by the SACIM team. This is an ongoing work that has to be sustained so as to let parents know about our existance and the possibilities to operate on children in need. SACIM is a non-profitable organisation 57 years and unfortunately the public and most probably young parents do not know us.

We need everybody to help sick and needy children.

I thank the Board members for their support, the staff members for their hard work during the year 2023.

It was a real honor for me to serve SACIM to enable sick children to have a better life and future.

GUIDELINES

I. Aims of the Society

The aim of the society is to provide aid to needy Mauritian children suffering from conditions which cannot be operated upon in Mauritius and which can be operated abroad, and to obtain such treatment abroad.

The object of SACIM is extended in specific circumstances to any other cases which may be treated locally by specialized health care professionals having the required expertise and in adequate health care centers.

II. Constitution

The Society is the official body recognized by the Government for attainment of its aims and is registered with the Registry of Associations. Its constitution is fully formulated and conduct of the Association's business is in accord with the directives of the Registry of Associations.

The Society's affairs are governed by a Central Committee consisting of a President and two Vice-Presidents, one of whom must be a doctor, an Honorary Secretary, an Honorary Treasurer and totaling fourteen members chosen at the Annual General Meeting or co-opted by the Central Committee.

Members of the Society pay an annual Subscription of Rs 600/-.

III. Referral to the Society

Children must be below the age of 18 years.

Before any child can be considered for aid by the Society, a medical certificate from the treating doctor must be supplied, attesting that the child suffers from a surgical condition which cannot be treated in local public hospitals. It is to be noted that Mauritius is a welfare state and treatment in hospitals are free of charge. For same if treatment can be obtained abroad or locally in non-governmental clinics, X-rays, ECGs, Echo and investigation report must accompany the medical report.

Children under one year of age and suffering from cyanotic congenital heart disease other than definite Fallot's tetralogy as well as children suffering from rheumatic heart disease or from significant mental defect may be accepted for aid by the Society after individual consideration of each case.

This referral will also be extended to any other cases which may be treated locally by specialized health professionals having the required expertise and in adequate health care centers.

IV. Medical Examination

After referral to the Society and if fulfilling the above criteria, the child is referred to a panel of SACIM doctors for their opinion.

For all cases, the opinion of two doctors on the SACIM panel is required. Both must agree upon the necessity for referral of the child abroad or locally if available and sign to that effect. Where the doctors do not agree, a third opinion is sought and a meeting of the panel of SACIM doctors is called.

Investigations are undertaken free of charge in Government hospitals. Should a child suffer from a condition which requires consultation and/or investigation by a specialist outside Government Medical Service, provision exists for payment of a fee to a private practitioner undertaking such work.

This referral will also be extended to any other cases which may be treated locally by specialized health professionals having the required expertise and in adequate health care centers.

V. Social Circumstances

On initial referral to the Society, a preliminary social enquiry is made by members of the SACIM staff or Committee. After medical examination, a full enquiry into the social circumstances of the child's parents is undertaken by the staff of the Probation & After-Care Service.

Notwithstanding the above, in urgent cases, an affidavit has to be sworn by the responsible party of the child to:

- (1) Confirm his social situation
- (2) State the donation to be made to SACIM

For emergency cases, the responsible party will need to take an undertaking with SACIM pending the affidavit.

VI. Acceptance of Cases

Criteria to be satisfied for SACIM to accept cases:

- (a) The child is aged less than 18 years at time of referral.
- (b) The family income is not more than the amount as stated in the National Solidarity Fund
- (c) Notwithstanding (b), the committee may exceptionally approve a case based on the social report.





Conditions to be accepted by the responsible party

The Central Committee considers each case individually in committee after discussion of the medical and social reports. In urgent cases a telephonic Committee suffices. Aid can only be given when the parents accept the following conditions, where applicable:

- (a) SACIM will decide to which country and to which center abroad the child will be sent.
- (b) The Committee, on the advice of the doctors who have seen the child, will decide when the child will go.
- (c) Every effort is made to see that children travelling unaccompanied by a parent accomplish the journey without mishap and suffer no deprivation of affection while abroad. However, many medical centres abroad and our Committee Doctors agree that recovery of younger children is aided by the presence of the mother. Some mothers or, in an exceptional case, the father, therefore accompany young children abroad. Such decision is taken after considering each individual case by the SACIM Committee but, under no circumstances can a second parent accompany a child.
- (d) Should a child die for whatever reason while abroad, the Society will pay for the funeral, according to the child's religious faith, in the country of decease but will in no circumstances be responsible for the expenses involved in the return of the body to Mauritius. Consideration might be given to sending the father abroad immediately in such a case.
- (e) In the event of the child's death the return ticket will remain the property of the Society.
- (f) Parents are asked to agree to accept publication of the child's name and brief details of his condition and treatment.
- (g) Parents are also asked to give permission for post-mortem examination in the event of death.

VII. Aid Given

The Society may, after consideration of the social circumstances of the child's family, decide to give full aid, paying all expenses involved in connection with arrangements for departure (return ticket, etc.) and any expenses incurred abroad.

A donation may be asked from the parents, based on the social report. Such a contribution is considered strictly as a donation to the Society and not as a contribution towards expenses involved in sending any particular child abroad.

Notwithstanding the above, for children treated locally, the responsible party may be asked to contribute partly to the local treatment of the child based on the social report.



REPORT OF THE AUDITORS TO THE MEMBERS

We have audited the accounts of Society for Aid to Children Inoperable in Mauritius set out on pages 14 to 16.
